# **Remote betting host real events licence**

This licence will allow you to provide facilities for betting on real events (but not virtual events) by means of remote communication (for example, a website)

Licences and Fees

Regardless of where you are based in the world, you need a licence from us if:

- you are providing facilities for gambling to consumers in Great Britain online (or through any other means of remote communication)
- any part of your remote gambling equipment is based in Great Britain.

There is a remote operating licence for each type of gambling activity you might want to provide.

### Hosts

Some **gambling software** businesses provide facilities for remote gambling by making their games or betting content available to customers of other operators. For example, rather than supplying its software directly to remote gambling operators, the gambling software business hosts its own sportsbook on its own server, and those betting markets can be accessed by customers of other operators through those other operators' websites.

If you are a **gambling software** business that provides facilities for remote betting on real events **but only** in circumstances in which you host those facilities through other operators' platforms, then you may be eligible to hold a **remote betting host (real events) operating licence**.

This licence will allow you to provide facilities for betting on real events (but not virtual events) by means of remote communication (for example, a website) **and only** in circumstances where the following criteria are met:

- You hold a gambling software operating licence, and
- You do not contract directly with any of the customers who place bets on the facilities you provide ie only customers of another operator can access your betting facilities via that other operator's website or app.

# **Current annual fees**

Your first annual fee is due 30 days after your licence is issued and is reduced by 25% (ancillary and linked licence annual fees are not subject to this reduction).

After this, fees are due every year before the anniversary of the day your licence was issued.
